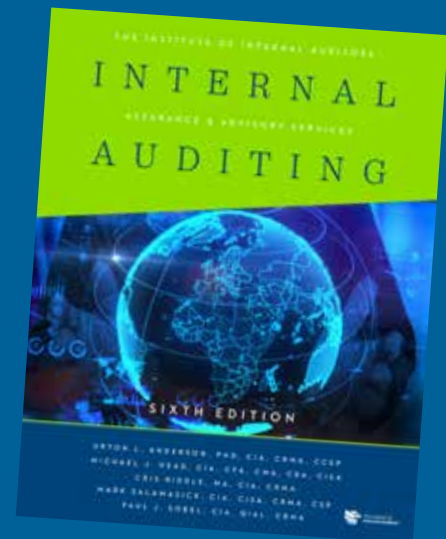
Advancing Internal Audit Education
