
THE 11TH AFRICAN FEDERATION OF INSTITUTES OF INTERNAL AUDITORS CONFERENCE 2025 REPORT



26 - 30 May 2025

Rwanda, Kigali



EXECUTIVE SUMMARY

The African Federation of Institutes of Internal Auditors (AFIIA) in collaboration with The Institute of Internal Auditors Rwanda hosted the 11th AFIIA Conference at the Kigali Convention Centre under the theme, "Building Bridges, Inspiring Change". The AFIIA conference is held annually and is hosted on a rotational basis by member countries across the continent. The AFIIA Conference provides a platform for members across the African continent to unite with a shared voice, engaging in discussions on critical issues and opportunities that go beyond collaboration, with the goal of strengthening and better serving African member Institutes. The key activities of the conference included presentations, workshops, panel discussions and networking sessions. The programme was arranged into 4 Major events: The AFIIA Leadership Workshop, exclusively for Affiliate Leaders, The Governance Forum which ran concurrently with the AFIIA University and the Main Conference.

AFIIA LEADERSHIP WORKSHOP

Affiliate Leaders from across Africa convened to collaboratively shape and advance the future of internal auditing at the AFIIA Leadership Workshop, facilitated by the IIA Global on the 25th May 2025 at Kigali Marriot Hotel. The President of The Institute of Internal Auditors Botswana, Ms. Gontle Khupe participated in this Workshop.

The workshop featured a series of dynamic and collaborative sessions that focused on four key pillars: advocacy, education, certification, and member engagement. Participants shared best practices, explored innovative strategies, and aligned on collective goals to enhance the impact and relevance of the internal audit profession across the region. Key outcomes included the development of actionable plans to strengthen advocacy efforts, expand professional development opportunities, promote certification pathways, and deepen member engagement.

Legislation

One of the key discussion points was the advancement of legislative initiatives aimed at recognizing and regulating internal audit. AFIIA leaders emphasized the need for a legal framework that recognizes internal audit as a critical pillar of governance, risk management, and accountability in both the public and private sectors, as this has been a challenge.

The discussion highlighted how legislative backing would standardize internal audit practices, enhance the independence of internal auditors, and strengthen compliance with

international standards. Affiliate Leaders also agreed that this would elevate the profession's credibility, ensuring internal audit functions are empowered to effectively safeguard organisational resources.

A discussion was held around the African Internal Audit Model Act – Model Legislation for African National Institutes, Developed and Endorsed by AFIIA and IIA Global, drafted to support Institutes in regulating and legislating the profession. Ms. Khupe committed to engaging regional bodies, policy makers and professional bodies in Botswana to regulate the internal audit profession as she strongly believes that this would be a significant step towards placing internal audit as a key driver of Governance in Botswana.

GOVERNANCE FORUM

The African federation of Institutes of Internal Auditors (AFIIA) Governance Forum, held

from the 26 – 27th May 2025 at Kigali Convention Centre, brought together Affiliate Leaders and Key Stakeholders from across the continent to engage in high-level dialogue on the strategic direction of internal auditing in Africa. Representation from The Institute of Internal Auditors Botswana included the President of IIAB, Ms. Gontle Khupe and the Past President, Mr. Lovemore Katukula This year's Forum served as a platform for collaborative governance, informed decision-making, and alignment on continental priorities. The agenda featured focused sessions and panel discussions, each designed to strengthen the capacity and influence of internal audit institutes within their respective jurisdictions.

The speakers and panellists included Senior Representatives from National Institutes of Internal Auditors, Governance Experts from International Organisations and Chief Audit Executives from major African Corporations and Government Bodies.

- Governance in the Digital Age
- Integrating ESG into Corporate Strategy
- Effective Risk Management as a Pillar of Good Governance
- Setting the Tone at the Top
- SOE's Enhancing the Effectiveness of Board of Directors
- Governance Failures: Where are Internal Auditors

Key outcomes from the Forum included actionable commitments to reinforce collaboration among member institutes, a roadmap for harmonizing governance practices across the region, and the reaffirmation of AFIIA's role as a unifying voice for internal auditors in Africa. The Forum reaffirmed the importance of strong governance structures and shared leadership in advancing the internal audit profession and ensuring its relevance in addressing Africa's Governance and accountability challenges.

The AFIIA Governance Forum concluded on a high note with a Cocktail Party held at The Intare Conference Arena, providing a

celebratory atmosphere that recognised the collaborative spirit and achievement of the Forum. The Cocktail Party not only marked the successful close of the Governance Forum but also reinforced a shared commitment to advancing excellence and unity within the internal auditing profession in Africa.

AFIIA UNIVERSITY

The AFIIA University was held alongside the Governance Forum, at Kigali Marriott Hotel. The sessions were designed to capacitate Internal Auditors with fundamental skills to enhance their auditing abilities of emerging risks, topical issues and technologies. The topics presented included the following:

- Global Internal Audit Standards: Understanding and Implementation
- Internal Audit's Role in Fraud Detection and Prevention
- Cybersecurity Audits: Best Practices and Challenges
- ESG Audits; Emerging Trends
- Communication and Reporting Skills for Internal Auditors
- Risk Based Auditing: Strategies for Enhanced Risk Management

THE AFIIA CONFERENCE

The Institute of Internal Auditors Botswana proudly participated at the 11th AFIIA Conference, which took place from the 28 – 30 May 2025 at The Kigali Convention Centre, Kigali Rwanda, under the theme, "Building Bridges, Inspiring Change." The AFIIA conference brought together internal audit professionals, governance leaders, policymakers and stakeholders from across the continent. IIAB was proud to be represented by Ms. Gontle Khupe – President, IIAB and Mr. Lovemore Katukula – Past President IIAB, along with members of the IIAB that attended the Conference.

The Opening Ceremony started off on a vibrant note, with delegates treated to captivating performances from local singers and traditional dancers. The cultural showcase brought a sense of excitement and unity, setting a celebratory tone for the event while highlighting Rwanda's rich heritage.

The Conference was officially opened by The Minister of State in Charge of the National Treasury, Honourable Godfrey Kabera. In His address, the Minister pledged his commitment to support and advocate for the advancement of internal audit, recognising it as a cornerstone of good Governance and organisational resilience. This pledge is in alignment with AFIIA's strategy and reinforces AFIIA's ongoing efforts to engage policy makers and

professional bodies to drive legislative reforms that elevate the profession's credibility and impact.

The conference featured diverse technical presentations, panel discussions and workshops covering, but not limited to, emerging technologies and their impact on internal audit, ESG and sustainability reporting, public sector audit transformation, data analytics and digital audit tools as well as cybersecurity risks and audit response. Emphasis was made that internal audit must continue to evolve by embracing innovation and aligning its mandate with emerging organisational risks.

Speakers emphasized the need for internal audit functions to be empowered and fully integrate into governance structures, pressing that the internal audit profession should be recognised as a key advisor to the board, beyond compliance. Several speakers addressed region – specific challenges such as political interference, weak enforcement of Government codes and limited auditor independence. Success stories from selected countries, illustrated how reforms and ethical leadership commitment can yield results.

Based on the presentations and discussion, there was a consensus on the need for integrated risk management approaches and Boards were encouraged to fully engage with internal audit to identity and mitigate emerging risks. It was noted that there is a growing recognition of internal audit as a catalyst for

improved Governance and that professional Institutes must support this shift through advocacy training.

The conference served as a hub for peer engagement, with strong participation from National Institutes across Africa, Representatives from Global and Industry Professionals and Thought Leaders. Discussions focused on Cross- Border collaboration opportunities, standardisation of internal audit practices and professional development pathways for African auditors. There is appetite and momentum for a more unified African Internal Audit voice, with AFIIA playing a key coordinating role.

Signing of MOU Between AFIIA and IIA Global

A historic and remarkable milestone was achieved with the signing of a Memorandum of Understanding (MoU) between AFIIA and IIA Global, marking a significant step forward in the provision of support and capacity-building initiatives aimed at strengthening internal audit advocacy across the African continent. This strategic partnership comes at a crucial time, as several Institutes in Africa continue to face challenges related to legislation and regulatory recognition of the internal audit profession within their jurisdictions.

As part of this collaboration, a dedicated resource will be engaged to spearhead, manage, and coordinate the advocacy agenda for the continent, ensuring a unified and impactful approach towards elevating internal audit standards and influence across Africa.

IIA Botswana

The Governance discussions strongly resonated with the challenges and realities experienced in Botswana, particularly the need for:

- Strengthening independence of audit committees
- Increased investment in public sector Governance
- Greater visibility of internal auditors in decision making forums

- Engage with policymakers to advocate for stronger internal audit, governance and risk frameworks in both public and private sectors
- Promote ethical leadership and transparency as a national agenda item
- Ensure knowledge sharing to disseminate insights gained from Board activities
- Drive innovation in internal audit methodologies through partnerships

The AFIIA Conference reaffirmed the vital role that internal auditors play in shaping resilient, transparent and accountable institutions. IIA Botswana remains committed to advancing these principles and strengthening governance across Botswana's institutions, in alignment with the broader AFIIA mission.

IIAB Meeting With IIA Global

Ms. Khupe and Mr. Katukula had the privilege of meeting with IIA Global staff to engage in insightful discussions on the current developments within the internal audit profession, as well as to share IIAB's achievements and challenges. During the meeting, updates on membership growth and certification statistics were presented, and a critical topic of discussion were the changes and new requirements in the IIA certification programs, specifically CIA and IAP.

The IIAB team highlighted its successful initiatives in Botswana during the May celebrations, including the CAE and Audit Committee Chairpersons' Breakfast Session, the IIA Marathon, and the IIA Walk. IIA Global staff commended IIAB for its commitment to promoting and advocating for internal audit, expressing admiration for the remarkable growth of the Institute given the relatively small internal auditor population in Botswana.

Furthermore, IIA Global emphasized the importance of amplifying IIAB's voice and presence in regional and global forums through consistent participation, leadership, and knowledge sharing. This encouragement aligns with IIAB's ongoing initiatives to position Botswana as a strong contributor to the internal audit profession on the global stage.

AFIIA Annual General Meeting

The AFIIA Annual General Meeting was a key official segment of the conference, convening Affiliate Leaders from Institutes in Africa. The AGM served as a platform to review AFIIA's strategic direction, operational progress, governance matters and regional collaboration efforts as well as to vote for the new AFIIA Governing Council. Ms. Gontle Khupe, President IIAB and Mr. Lovemore Katukula, Past President IIAB, represented Botswana, with Ms. Khupe voting on behalf of the IIAB as the Top Elected Officer of the IIAB.
