

<u>Global IIA Standards - Tidbits</u>

Well, now that I have read and somewhat digested the Global Internal Audit Standards (effective 1/25), here are some tidbits to be aware of:

- Standard 7.1 Organizational Independence: The Chief Audit Executive (CAE) must inform the Board/Management of any impairment to independence. There "may" be an independence issue when the CAE reports to a non-CEO such as the CFO, so planned safeguards must be discussed and put in place. For example, if the CAE reports to the CFO, and the engagement area is accounts payable may impair independence.
 - I will discuss this element at the Audit Committee, make disclosures on reports, and potentially have another Executive VP review work as a "safeguard."
- Standard 4.1, 12.3: A discloser is required when the project does not follow the Global Internal Audit Standards, including the impact and rationale for noncompliance.
 - I plan on implementing an end-audit checklist, marking disclosures on the final report, and including the details of impact and rationale in the scope of the report.
- Standard 2.2: A discloser is required before accepting an advisory project that succeeds the previous responsibility of the auditor/CAE.
- Standard 2.2, 2.3, 7.1: Disclose if objectivity or independence is impaired in fact or appearance.
- Standard 11.3: Disclose if the project relied on the work of other assurance providers
