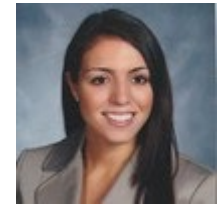
Chapter Events

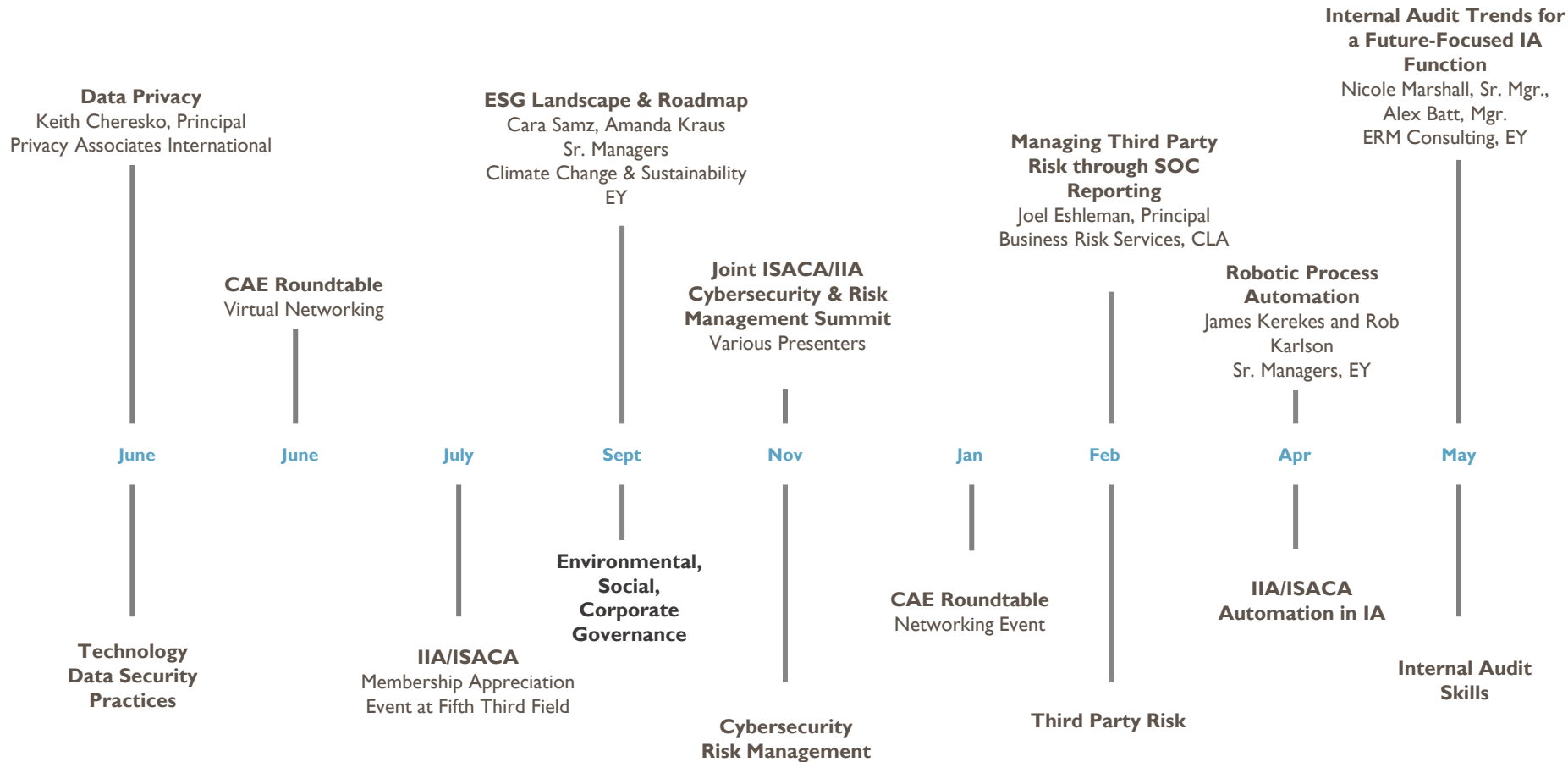
Member Appreciation Event with the Toledo Mud Hens at Fifth Third Field
