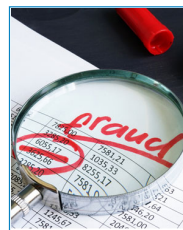

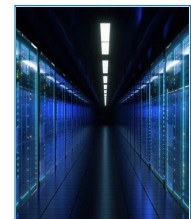

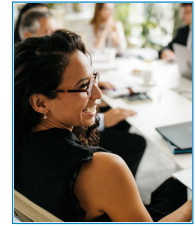
The World is Evolving... so is the IPPF!
