The Professional Certifications Board (PCB) provided conditional approval for online proctored exams in 2021, as a precautionary solution during the COVID-19 global pandemic. That conditional approval is set to expire as we retire the 2019 CIA syllabus.

To preserve the integrity of IIA certification programs, reduce misconduct cases, and enhance the testing experience for all candidates, the decision has been made to transition back to a <u>test center-only delivery model</u>. Effective 28 May 2025, online proctoring will be discontinued permanently. As part of this transition, the last day to register for online proctored exams will be 1 May 2025.


